	HOUSE CALL - INSULATION & SEALING	ELIGIBILITY DESCRIPTION	REBATE
To qualify for a rebate in this section you must have a "House Call" completed.			
Attic Insulation	Qualified CEE* Contractor installed - Must be recommended in "House Call" audit and add a minimum of R19 with ending R value of 49 or greater.	\$350 (capped at 50% of cost)	
Attic Air Sealing	"House Call" audit must be performed prior to work being conducted. All bypasses identified in audit must be addressed and work performed by Qualified CEE* Contractor. Retrofit only.	\$200	
Rim Joist Sealing	"House Call" audit must be performed prior to work being conducted. Rim joist sealing identified in audit and work completed by Qualified CEE* Contractor. Retrofit only.	\$150	
Wall Insulation	Qualified CEE* Contractor installed -Must be recommended in "House Call" audit. Minimum 450sq. ft. of insulation for rebate. Injection for empty wall cavities only. Exterior Rigid Foam: R5 or greater on already insulated walls. Retrofit only.	\$300 for Injection \$200 for Exterior rigid foam	
Bonus Water Heater	Program-qualified water heater (WH) to replace an orphaned water heater. Must replace atmospheric WH with power vent tank or tankless WH. Must be verified through audit.	\$100

Attic Insulation	Self Installed or Non CEE Qualified Contractor installed. Must add a minimum of R19 with ending R value of 49 or greater. Retrofit only.	\$200 (capped at 50% of material cost)	


	BATTERY-POWERED LAWN EQUIPMENT	ELIGIBILITY DESCRIPTION	REBATE
Push/Walk-Behind and Riding Lawn Mowers**	Residential customers only. New and battery-powered with a battery voltage of at least 36 volts. Corded and robotic mowers do not qualify for a rebate. Must enroll in or continue to participate in Residential Time-of-Use Rate for a minimum of 12 months.	\$50 push/walk-behind lawn mower \$100 riding lawn mower
